

**2019 REVOLUTION AND "SHAW'S FAMILY OF THE MATCH CONTEST**  
**OFFICIAL CONTEST RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**

1. Contest: 2019 Revolution and 'Shaw's Family of the Match' Contest (this "Contest").
2. Contest Period: This Contest begins at 9:00 a.m. (ET) on June 17, 2019 and ends at 5:00 p.m. (ET) September 25, 2019 (the "Contest Period"). The Contest Period is comprised of nine (9) Prize Periods.
3. Rules: These Official Contest Rules, together with the General Rules for all sweepstakes and contests sponsored by any of the Kraft Group Companies, comprise the entire set of Official Rules governing the Contest.
4. Eligibility: Contest open only to individual legal residents within the following states: ME, MA, NH, VT and RI. Entrants must have attained the age of majority in his or her state of residence as of the date of entry into the Contest.
5. How to Enter: There is one (1) method of entry for the Contest - online entry. To enter, complete and submit an official entry form at [www.revolutionsoccer.net](http://www.revolutionsoccer.net) during the Contest Period. As part of completing the entry form, the entrant must submit contact information and explain why the Revolution should choose his/her family as the Shaw's Family of the Match.

There are nine (9) Prize Periods, as set forth below. One (1) prize will be awarded following each Prize Period, subject to Section 7. Entries submitted at any time during the Contest Period are eligible to win during that Prize Period and each subsequent Prize Period during the Contest Period.

No illegible, incomplete, forged, or altered entries will be accepted. Limit: One (1) entry per person during the Contest Period. All entries become the exclusive property of the Sponsor and will not be returned. Multiple entries will be disqualified.

**Selection of Winner:** The Contest will be conducted over the course of the Contest Period. One (1) Potential Winner will be selected for each Prize Period for Prize Periods 1-9. For each Prize Period, a Potential Winner will be selected approximately 4-5 days prior to the next 2019 Revolution regular season home match (see Prize Periods in Section 5 above). All eligible entries received during the Contest Period will be included in the drawing for each Prize Period, subject to entry limitations. Winners will be selected by the Sponsor from all eligible entries received during the Contest Period, based on the entrant’s answer as to why their family should be the Shaw’s Family of the Match. Originality, creativity and compelling entries will increase the likelihood of winning. Winning entries to be chosen as soon as practicable following the close of each Prize Period. The winning entry will have two days to respond and claim the prize. The winning entries will be determined by the Sponsor in its sole discretion, and Sponsor’s decisions are final on all matters relating to this Contest.

## GENERAL RULES

1. No Purchase Necessary: **NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**
2. Conflict Between Rules: These General Rules shall apply to all sweepstakes and contests sponsored by any of the Kraft Group Companies, unless modified or superseded by the rules written for a specific sweepstakes or contest (the “Official Game Rules”). In the event that any provision of the Official Game Rules conflicts with any provision of the General Rules provided herein, the terms of the Official Game Rules shall prevail with respect to such matter. Each Sponsor or Administrator (as defined in the Official Game Rules) reserves the right in its sole discretion to interpret the rules of any sweepstakes or contest, and such interpretation shall be binding upon all participants. All entries become the exclusive property of the Sponsor and will not be returned. Any person who attempts to participate with multiple e-mail and/or street addresses, under multiple identities or uses any device or artifice to submit multiple entries in violation of the entry limitation will be disqualified. In case of dispute, an on-line entry will be deemed made by the authorized account holder of the e-mail address used to submit entry. “Authorized account holder” is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Proof of submission of an entry form does not constitute proof of receipt.
4. Selection of Winners: Winners of a sweepstakes will be determined from all eligible entries received in a random drawing held as soon as practicable after the close of the sweepstakes period by Sponsor, whose decisions are final on all matters relating to the sweepstakes. Winners will be notified by telephone or email, at Sponsor’s sole discretion. In the event that a sweepstakes has multiple prize periods, entrants may enter more than one prize period, but winners will not be eligible to win prizes in subsequent prize periods and non-winning entries will NOT be carried forward to subsequent prize period drawings. Miscellaneous: Sponsor and judges not responsible for late, lost, stolen, damaged, garbled, incomplete, misaddressed, postage due, or misdirected entries, mail or communications, for errors, omissions, interruptions, deletions, defects, or delays in operations or transmission of information, in each case whether arising by way of technical or other failures or malfunctions of computer hardware, software, communications devices, or transmission lines or data corruption, theft, destruction, unauthorized access to or alteration of entry materials, loss or otherwise. Further, Sponsor and judges not responsible for electronic communications which are undeliverable as a result of any form of active or passive filtering of any kind, or insufficient space in entrant's e-mail account to receive e-mail messages. The use of automated software or computer programs to enroll or to enter the sweepstakes or contest is prohibited and any individual who uses or attempts to use such methods to enroll or to enter will be disqualified. Sponsor disclaims any liability for damage to any computer system resulting from participation in, or accessing or downloading information in connection with, this sweepstakes or contest, and reserves the right, at its sole discretion, to modify, cancel, terminate or suspend this sweepstakes or contest should any virus, bug, technical failures, unauthorized human intervention or other causes beyond Sponsor's control corrupt or affect the administration, security, fairness, integrity or proper conduct of the sweepstakes or contest. In the event of any such cancellation, termination or suspension, a notice will be posted and a random drawing will be held from among all eligible, non-suspect entries received prior to such time. Sponsor reserves the right, at its sole discretion, to disqualify any entrant (and all of his or her sweepstakes or contest entries) from this sweepstakes or contest or any other promotion conducted now or in the future by Sponsor or any of its affiliates if he or she tampers with the entry process or if his or her fraud or misconduct affects the integrity of the sweepstakes or contest. Sponsors reserve the right to correct clerical or typographical errors in promotional materials.
11. Conditions of Participation. By participating in this sweepstakes or contest, each entrant accepts the conditions stated in these Official Rules, agrees to be bound by the decisions of the judges and warrants that s/he is eligible to participate in this sweepstakes or contest. By participating, entrants hereby release and agree to hold harmless the Kraft Group Companies, and each of their directors,

employees, officers, and agents, including without limitation, their advertising and promotion agencies, from any and all liability, loss or damages arising from or in connection with the awarding, receipt, and/or use or misuse of prize or participation in any prize-related activities.
